- Secretary's Report- Sue Cain
 - Changes to September minutes: add Julie to attendance list; change profit from Womens Run to \$249.51
 - Motion made by Grace, second by Vince to accept the minutes. Motion passed
- Treasurer's Report- Kevin Pasterchik
 - Kevin reviewed expenditures/income from the previous month
 - Kevin noted a YTD profit of \$929.10
 - Chris made the motion to accept the Treasurer's report, second by Tom C. Motion passed

 - STACs this year will be held at Pheasant Hill Golf Course on October 29th. George is spearheading the finish line effort and will need volunteers

 - Octoberfast will be held on October 15th. Fee structure has been changed so a runner can participate in both the 5k and the 10k for one entry fee. Currently over 100 runners have preregistered
 - Motion made by Sue and seconded by Tom C. to charge a flat fee of \$125 to provide finish line services for the race. Motion passed

 - Tom requesting \$350 to cover expenses for the Freeze. Motion made by Dan and seconded by Grace. Motion passed
